Do solar rebates work?

Several states offer rebate programs that cover some or all of the cost of purchasing a home solar system and/or battery storage. These rebates can work in addition with the federal tax credit to increase the savings of going solar. For example: Maryland offers a \$1,000 rebate for solar photovoltaic and solar shingle installations above 1 kW.

How much does a solar rebate cost?

In some areas, solar rebates can provide over \$5,000. Rebates also sometimes come with requirements. You may only be able to select specific equipment, or there could be a maximum or minimum system size restriction. You might only be able to work with certain solar installers that the rebate program supports.

How does a solar PV rebate work?

For example, if your solar PV system was installed before December 31, 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows:

Rebates and incentives are a crucial way to encourage broader adoption of solar energy and full home electrification across the country. These incentives will typically come from your utility, state government, or the federal government in the form of tax credits, property tax abatements, one-time rebates, or performance-based rebates.

State energy efficiency incentives are generally not subtracted from qualified costs unless they qualify as a rebate or purchase-price adjustment under federal income tax law.
