

What are the restrictions on electricity supply?

Restrictions on licensee's controlling or interfering with use of energy 22. Obligation on licensee to supply energy 23. Charges for energy to be made without undue preference 24. Discontinuance of supply to consumer neglecting to pay charge 25. Exemption of electric supply lines or other apparatus from attachment in certain cases 26. Meters 26A.

Is Indian Electricity Act 1903 repealed?

58. Repeals and savings.-(1) The Indian Electricity Act,1903 (III of 1903),is hereby repealed: Provided that every application for a license made and every license granted under the said Act shall be deemed to have been made and granted under this Act.

What is the penalty for illegal transmission & use of energy?

Penalty for illegal transmission or use of energy.-Whoever, in contravention of the provisions of section 30, transmits or uses energy without giving the notice required thereby, shall be punishable with fine which may extend to five hundred rupees, and, in the case of a continuing offence, with a daily fine which may extend to fifty rupees. 1[44.
