

Who is Sofia Energy Agency?

Sofia Energy Agency was established in July 2001 under the SAVE II Program of the European Union. As specified in the contract with EU, the newly established agencies, ENERGIEBUREAU LIMBURG (Holland) and APEA (Italy) are partners of SOFENA (Bulgaria) and will coordinate their activities during the three years term of the contract.

What is the energy community in Sofia?

Ms. Galeva presented the model of an energy community, which is being implemented on the territory of the Sofia Municipality, with the support of the Vitosha Municipality. It will be the first energy community in the capital, with the goal of becoming a model for replication among other district municipalities.

How has Bulgaria's energy policy changed under Borisov?

Under the leadership of Prime Minister Boyko Borisov, Bulgaria's energy policy began to shift toward closer alignment with the European Union. Borisov's government, which came to power in 2009, was more sceptical of Bulgaria's heavy reliance on Russian energy.

Is Bulgaria getting more solar power?

Over the past year, Bulgaria has made considerable progress in expanding its renewable energy capacity, particularly in solar power. Solar energy production has surged from one gigawatt (GWh) in 2019 to more than three GWh today, with solar accounting for nearly half of the country's electric capacity from renewables.
